ENGINEER'S REPORT

Mr. Coldren reported that the Act 537 Plan was sent out a second time to the neighboring municipalities who should have interest in the plan. No written comments have been received from anyone for the second time. At this point, we would like to finalize the report and present it to the Township. We have return receipts that we'll include in the appendix of the report so that DEP knows that we did attempt to get comments. Mr. Coldren spoke with WWMA who apparently has comments that have not yet been received. We hope to get the ball rolling again and get the 50% reimbursement for the plan.

Mr. Blenko asked if anything was likely to change before it was submitted to the Township. Was a copy provided to John Shepherd for every Commissioner?

Mr. Coldren replied he gave one draft copy to John to review, but has not sent additional copies for the Commissioners. Mr. Blenko suggested requesting comments from Mr. Shepherd by a certain due date. Mr. Coldren said he would check back with John to see if he had any comments. Mr. Blenko said he doesn't want to see Dave finalize the plan and then have to do it again if someone adds comments. He needs to say he needs comments within a certain time frame. Mr. Coldren said maybe it should be left up to the Township whether or not we have to come in and present the draft visually.
